Peter Eisenhardt, 2015 - Present

Peter Eisenhardt is a finance professional with extensive experience across a full range of products, functions, and regions during a 30+ year career at Bank of America Merrill Lynch and J.P. Morgan. As Head of Euro Commercial Origination and Marketing, he was an integral part of market-leading teams at BAML and JPM that won awards including *International Financing Review's* "ECP House of the Year". He chaired ICMA's Euro Commercial Paper Committee from 2007-12.

Peter was named to *Euromoney's* "Dream team of the European Capital Markets" in 2004.

After starting his career at J.P. Morgan in New York in liability management, he traded money markets before launching the bank's OTC bond options trading business in Tokyo. He moved on to London as founder of the bank's European repo business in 1990. Peter managed financial institution credit risk from 1996-99.

Prior to joining ICSA, he completed successful mandates in consulting, training, and writing.

Peter is trustee and treasurer of The Creative Dimension Trust, a charity which offers workshops taught by world-leading specialists to less advantaged youth to help them pursue careers where fine hand skills are prerequisite.

Anita Millar founded ADM Risk, Regulation & Strategy Ltd (ADM) in 2005 to offer prudential and market infrastructure related risk and regulatory advisory services. In 2008, she joined Northern Trust, designing, developing, and implementing a suite of risk audits before relaunching ADM in 2009.

Anita's expertise in risk management is rooted in training undertaken at the TD Bank Financial Group (in Toronto), where she managed counterparty credit risk on derivative transactions. In 1997, she moved to London and joined NatWest and remained through its takeover by Royal Bank of Scotland. Her work involved leading a counterparty risk team through a changing product offering, new organisational structure, and Basel II.
