1. Age Categories & Rules 📄 ✨

Children Under 5 Years Old 👶

Children under the age of five 👶 are not allowed to travel alone 🚫 and must fly with a parent or adult aged 18+ 👨‍👩 on the same reservation. 🛫👤 4. Flight & Routing Restrictions ✈️📋

UM service is generally available only on nonstop or direct Virgin Atlantic flights 🛫. Connecting itineraries or partner Airways are usually not permitted 🚫🔄 to ensure consistent supervision 👤👤.
